#### **Submissions:**

- 1. Participants unanimously agreed that all leaders must work in unity to achieve the AU Diaspora objectives within this region.
- 2. A call was made to compose a database of all African Australian organisations, listing the date of incorporation, aims and objectives, and how its operations aligns with the AU objectives.
- 3. Subject to further discussions, participants:
- 3.1. Recalled that The African Diaspora in Australia (& Asia Pacific) Project is a neutral initiative, not affiliated with any organization. The idea is to amalgamate the collective strength and voice of the African Diaspora in Australia, Asia Pacific towards a common goal. The body's objective is to achieve the best possible outcome for the implementation of the AU diaspora projects within this region. The conduct of this project is guided by the objectives and processes articulated in the DECLARATION OF THE GLOBAL AFRICAN DIASPORA SUMMIT SANDTON, JOHANNESBURG, SOUTH AFRICA 25 MAY 2012; and the REPORT ON THE AFRICAN UNION DIASPORA MINISTERIAL CONFERENCE, 16-18 NOVEMBER 2007, JOHANNESBURG, SOUTH AFRICA.
- 3.2. Also recalled the suggestions made by the Community Leaders Group Chair, Dr Apollo Nsubuga-Kyobe in regards to Methodological Guidelines for inclusion into or being an African Peak Organisation member of the African Diaspora in Australia (& Asia Pacific) Project. These recommendations are:

a. The aims, mission, vision, and objectives of the relevant African Peak Organisation must be consistent or in harmony with those of the African Diaspora in Australia (& Asia Pacific) Project.

The relevant African Peak Organisation must be having a national or broadly unifying focus as well as a clear bridged linkage between Australasia/Asia Pacific and countries of the African continent, people, regional markets and AU in particular, as well as the Diasporas Interests.

- b. The constitution of the African Diaspora in Australia (& Asia Pacific) Project will examine these proposals, then well define full membership in types, categories, voting rights and how the governing body will be constituted. The relevant African Peak Organisation will provide the basis to the governance of the African Diaspora in Australia (& Asia Pacific) Project, but representation to the respective forums including external global or international forums will be on the basis of expertise as agreed and recommend by the Governing Body.
- c. The relevant African Peak Organisation must have core competencies to serve certain defined benefits as should be specified by the African Diaspora in Australia (& Asia Pacific) Project from time to time,
- c. The relevant African Peak Organisation must have fairly representative "Goodwill" of the people of the communities supposed to be represented into the cohort of the African Diaspora in Australia (& Asia Pacific) Project. Thus, such organisation must be of well approved functional dealings within the respective matter(s) connected with the African-Australians or countries of the African continent or the African people even if they are outside Africa, e.g. in Europe.
- d. The relevant African Peak Organisation must be a significant contributor at the point in time especially when such organisation is seeking to be a member, or partner or collaborator with the African Diaspora in Australia (& Asia Pacific) Project. The level of significance in this regard will be determined by the Executive Board (ruling body) of the African Diaspora in Australia (& Asia Pacific) Project from time to time,
- e. The relevant African Peak Organisation must demonstrate the knowledge, technical know-how and capacities in assessing, monitoring, articulating and participation for developments and changes which should be positively occurring within Africa, AU, regional markets, and within African renaissance aspects paying regard to responsibility, accountabilities, and growth (moving to next better step).
- f. The relevant African Peak Organisation must be paying regard to commonly referred to Human rights principles for example; matters of fair access and equity, gender and age balances, non-discriminatory required tendencies, social justice and responsibilities, ethical principles, sustainability issues particularly in connection with extraction industries as well as implications to/of the respective country's industrial and special export/import orientation zones (SEZs).

The relevant African Peak Organisation must be up to tasks. Please members expand on the above views.

3.3. Further recalled the proposals by the Chair of the Academics Group, Dr Chika Anyanwu, in regards to the legal framework of **The African Diaspora in Australia (& Asia Pacific) Project ( also known as the AU Pan African-Australian Diaspora Network (PAADN)):** 

# a. AIM

The establishment of the Pan African-Australasian Diaspora Network, herein known as PAADN, to collaborate with the African Union and its intergovernmental council to ensure

that identified projects by members of the African diaspora in the Australasian region align with African development agenda.

#### b. Mission

To develop a sustainable relationship between members of the African Diaspora living in the Australasian region and motherland Africa, through collaborative engagements with the African Union, African Heads of Mission and African missions in the regions of our residence.

#### c. Vision

To bridge the gap between African developmental aspirations and their implantations through international benchmarking and connection

#### d. Our Values

We will carry out our work and strive to achieve our goals in ways that are consistent with good governance, international ethical values, legal frameworks of the countries of our residence, service to our countries of residence and motherland Africa, in order to inspire others to emulate integrity and trust, value diversity, be creative and innovative, serve with transparency and humility and be sustainable in our daily activities.

#### e. Terms of Reference:

The formation of PAADN is in response to the Global African Diaspora Summit, Sandton, Johannesburg, South Africa. 25 May 2012 Diaspora/Assembly/AU/ /Decl (I) wherein the Heads of State and Government of the African Union, the Caribbean and South America

TAKING COGNIZANCE of the dialogue carried out between Africans on the Continent and representatives of the African Diaspora in various regions of the world, including North America, South and Latin America, Europe and elsewhere;

RECALLING the Constitutive Act of the African Union that is guided by a common vision of a united and strong Africa based on a partnership between governments and all segments of society in order to strengthen cohesion and solidarity among its peoples;

ALSO RECALLING the Protocol on Amendments to the Constitutive Act of the African Union adopted by the First Extra-Ordinary Session of the Assembly of Heads of State and Government in Addis Ababa, Ethiopia in January 2003, and in particular Article 3(q) which invites the African Diaspora to participate as an important component in the building of the African Union

- 2 (b). It was agreed that the body will be incorporated under a federal registration framework and that, post registration, the body will be managed by a designated ad hoc committee for a significant period of time to enable continuing review of the legal frameworks, and to enable full maturity and development of the body's various project arms.
- 2 (c). It was suggested that the legal framework will reflect the tenure and how the organisation will be managed within the development period and maturity period. Also, the secretariat structure including staffing, remunerations and duties will be reflected in the legal framework.
- 2 (d). The chairs will research suitable secretariat and corporate structures. They will make a draft submission to the Facilitator before the next meeting on 6th of July.

- 2(e). The law society or any capable body, including DFAT's African Desk, may be consulted to vet the draft legal framework for consistency with local laws and the government's direction.
- 3 (a). A consensus was reached that, whilst we work towards the body's registration, a member's registered organisation should be appointed to assist with sponsorship and grant applications. This is an interim arrangement to mobilize financial resources for the body's pre-incorporation activities, including the finances for its secretariat, African Union's pre-launch visit to Australia and our public consultative forums in September.
- 3(b). Mr David Malinda indicated that the African Community Organisation of South Australia (ACOSA) would be happy to assist with grant application. (You are also encouraged to nominate to assist with fund raising.)
- 4. The dates for the African Union's pre-launch visit to Australia and our public consultative forums in September will be presented to members when finalised.
- 5. The Chairs indicated interest to conduct a survey to probe what are the most important projects the African Australian diaspora can undertake in each African country.

- 5. Take critical consideration of the multidimensional facets of Africa's social, cultural, political and economic climates in its project designs and execution
- 6. Where possible, regional representation should be encouraged to infuse diversity in language and socio-cultural know-how to the body's operational frameworks.

All applauded the Chair, Dr Chika Anyanwu, for drafting the legal framework that will now be subject to further reviews. Participants agreed to forward their amendments to the Chair as soon as possible.

# Collaborative working relationship with peak African organizations within Australia Dear All.

This is responding to the task of proposing collaborative Methodologies, Accountabilities and Review Mechanisms to be grounded into policies and procedures for the working relationships with peak African organizations within Australia and the Asia Pacific region. The suggestions for Community Leaders and for the African-Australian diasporas are triggers from Dr Apollo Nsubuga-Kyobe for proposals or highlights towards developing policies and procedures for collaborative working relationship with peak African organizations within Australia and the Asia Pacific region. Among other things, this is particularly for proposing designs aimed at helping to select qualifying organisations that would fit the above mentioned criteria (of collaborative methodologies, accountability and review mechanisms) in linking with AU. The suggestions are also for further recommendations for rewards or incentives for the participating members in this African Australians diaspora project.

First Note	:

Characteristics of the African Australians Communities (the Diasporas in Australasia & Pacific).

- Highly driven by their background characteristics which may include:
  - Limited unity of purpose and strategic intends and approaches to do so.
  - Non- homogeneity of the groups, thus instead of diversity being a strengthen it becomes a weakness
  - In addition the negative diverse effects arise with their modes of arrival and recognition of the competencies brought with them,
  - Social/life skills
  - Derivatives from the respective colonial legacies, and ways societies were constructed in Africa
  - Educational status, easy transformation and reasonable adaptation
  - Socioeconomic status and misrepresentation by media,
  - Religion (faith communities), culture, ethnicity and linguistic cohorts.
  - Time spent in refugee camps and other forms of transitions,
  - o Rural and urban background, and
  - Other factors (these are many), e.g. full knowledge of their background by use of valid reliable information as may be added to what can be called "African value versus values in the respective ethnic or tribal groups".

However, the suggestions below are aimed at triggering discussion, thus jointly enhancing meaningful and relatively appropriate outcomes (see proposals further below):

# **Second Note:**

African-Australian (including Asia Pacific Ones) Communities' organisations are generally structured based on certain criteria, which are as follows; and such has tended to be the basis of their formation, indeed their constitutional preambles or focus as well take a similar trend:

 Issues Based Criteria including the need of pulling African-Australians (diasporas) into broadly based pool

Examples may include: Africa Australia Association (Doing Business in Africa: Opportunities in International Education & Training), Somali Relief Association, Australia Southern Sudan Support Group, The African Soccer Club of Victoria, The African Think Tank Inc.; The African Studies Association of Australasia and the Pacific (AFSAAP); Africa Day Australia Inc.; Australia-Africa Universities' Network (AAUN); Africa Media Australia Inc.; African Australians Project: Migration between Africa and Australia: a demographic perspective (2010); African Communities Foundation Australia; Australia Africa Business Council; Australia Africa Infrastructure Project, Afro-Australian Students' Association, Federation of the African Communities Council (FACCA), Afro-Australian Association, African-Australian Mining Association, and the like organisations.

Here questions arise as to what extent these organisations could be harmoniously pursuing relative agendas for example of enhancing equally beneficial linkages between countries of the African continent, people, and Australasia or Asia-Pacific region and the referred to people!!!! Also, to what extent do these organisations pursue their agendas consistent with the AU's objectives of establishing "Diasporas" as the 6th Regional Market under the AU's focus!!!! Which of these organisations' mission, vision, goals, and objectives appear to be consistent in line with AU Diaspora agenda as well as the African Australians diaspora project?

Answering to these exclamations or questions as those above, it is likely to enhance our suggestions towards the policies and procedural grounds.

# • National/Country Focus criteria

Examples may include: Nigerian Association, Ugandans Association, Zimbabwe Association, Ghana Association, Tanzanian Association, South Sudanese Community Association of Australia, Zambian association, Botswana association, Liberian Community Association of Australia, Eritrean Community Association of Australia, and the type of organisations.

#### • Ethnic or Tribal Based Criteria

Examples include: Australian Oromo Community Association, The Harrarian Community of Australia, Dinka Community Association of Australia, Ethiopian Tigrian Community of Australia (there are other four under these heading; one for elderly, women, men, and youth), and a few others in this category.

• Regional Based Criteria (these may be an Australian or African Region)

Examples may include: African Community of Dandenong, Goulburn Valley African Communities Association, The East and Central African Community of Victoria, The Horn of African Network Communities, The African Community Association of Moonee Valley, Goulburn Valley Congolese Association, Somalia Women's Group of Western Suburbs Melbourne,

• Other Category (this covers those not fitting into the above four mentioned categories).

Examples may include: The African Communities Elderlies Association (based on age), The African Islamic Call society of Australia, The African Preston/Northcote/Dandenong Church of Pentecost Group (based on religion), Somalia Senior Citizens, African Young People Association of Victoria, Horn of Africa Young Mothers' Association and the like organisations.

#### Third Note:

The foregoing suggests complexities in defining the collaborative methodologies, accountabilities and review mechanisms for policies and procedures for working relationships with peak African organizations within Australia and the Asia Pacific region.

Nevertheless, the following are the suggestions as Methodological Guidelines for inclusion into or being an African Peak Organisation member of the African Diaspora in Australia (& Asia Pacific) Project:

- The aims, mission, vision, and objectives of the relevant African Peak
  Organisation must be consistent or in harmony with those of the African
  Diaspora in Australia (& Asia Pacific) Project.
- The relevant African Peak Organisation must be having a national or broadly unifying focus as well as a clear bridged linkage between Australasia/Asia Pacific and countries of the African continent, people, regional markets and AU in particular, as well as the Diasporas Interests.
- The constitution of the African Diaspora in Australia (& Asia Pacific) Project will examine these proposals, then well define full membership in types, categories, voting rights and how the governing body will be constituted. The relevant African Peak Organisation will provide the basis to the governance of the African Diaspora in Australia (& Asia Pacific) Project, but representation to the respective forums including external global or international forums will be on the basis of expertise as agreed and recommend by the Governing Body.
- The relevant African Peak Organisation must have core competencies to serve certain defined benefits as should be specified by the African Diaspora in Australia (& Asia Pacific) Project from time to time,
- The relevant African Peak Organisation must have fairly representative "Goodwill" of the people of the communities supposed to be represented into the cohort of the African Diaspora in Australia (& Asia Pacific) Project. Thus, such organisation must be of well approved functional dealings within the respective matter(s) connected with the African-Australians or countries of the African continent or the African people even if they are outside Africa, e.g. in Europe.
- The relevant African Peak Organisation must be a significant contributor at the point in time especially when such organisation is seeking to be a member, or partner or collaborator with the African Diaspora in Australia (& Asia Pacific) Project. The level of significance in this regard will be determined by the Executive Board (ruling body) of the African Diaspora in Australia (& Asia Pacific) Project from time to time,
- The relevant African Peak Organisation must demonstrate the knowledge, technical know-how and capacities in assessing, monitoring, articulating and participation for developments and changes which should be positively occurring within Africa, AU, regional markets, and within African renaissance aspects paying regard to responsibility, accountabilities, and growth (moving to next better step).
- The relevant African Peak Organisation must be paying regard to commonly referred to Human rights principles for example; matters of fair access and equity, gender and age balances, non-discriminatory required tendencies, social justice and responsibilities, ethical principles, sustainability issues particularly in connection with extraction industries as

well as implications to/of the respective country's industrial and special export/import orientation zones (SEZs).

• The relevant African Peak Organisation must be up to tasks.

Please members expand on the above views.

# THE AFRICAN DIASPORA IN AUSTRALIA (& ASIA PACIFIC) PROJECT

African Diaspora in Australia (& Asia Pacific) Project is a neutral initiative, not affiliated with any organization. The idea is to amalgamate the collective strength and voice of the African Diaspora in Australia, Asia Pacific towards a common goal. Our objective is to achieve the best possible outcome for the implementation of the AU diaspora projects within this region. The conduct of this project is guided by the objectives and processes articulated in the AU DECLARATION OF THE GLOBAL AFRICAN DIASPORA SUMMIT and REPORT ON THE AFRICAN UNION DIASPORA MINISTERIAL CONFERENCE.

This forum has been designed as an important part of a series of consultative forums of all stakeholders from organizations to intellectuals, entrepreneurs and youths to contribute towards actualising the AU diaspora objectives within this region, as envisioned in the above mentioned documents.

Specifically, this forum has been convened to assist in setting the structure, processes and legality for a body "The African Diaspora in Australia (& Asia Pacific) Project" that will oversee the AU diaspora missions within this region.

So far, progress has been made in the first phase towards the body's formation, that is bringing together some of the best minds in Australia on board. We have also succeeded in the second phase, that is forming focus groups and assigning tasks to each team. The leaders of these focus groups and assigned tasks are detailed below.

We are currently on the third phase. The chairpersons are expected to take proactive actions to set agendas and schedule regular meetings for their groups. Including mobilising, motivating and managing their groups to achieve the assigned tasks below. The deadline for this phase was anticipated for December 2014 but now extended until June this year.

The current (third phase) tasks are designed to evaluate how participating leaders can work together in unity, within their groups, to achieve outcomes.

The fourth phase will entail collating all of the recommendations and reports from the focus groups to develop a constitution, structure, processes, procedures, working papers and target projects. Further, seed funds (generated by the group tasks to do so) will be used for

office/secretariat administration and conference expenditures, or as will be recommended by that group. Expected completion is by July/August.

The fifth phase is public consultations to fine tune a draft constitution, structure, processes and procedures, working papers and target projects. Completion is expected by November/December.

The sixth and seventh phase is incorporation and election of a Central Committee/Executive Board to oversee the body, subject to the constitution. Completion is expected by year end or early next year.

- 1) Preliminary discussions may focus on developing structures and processes for "The African Diaspora in Australia (& Asia Pacific) Project". Including its legal status, objectives, policy guidelines, implementation strategies and leadership structure.
- 2) Future discussion areas suggested by Mrs Juliana Nkrumah AO include: "leadership, women, professionals, government, policy, Human Rights and Policing". She recommends that "Human Rights will have to form a cross cutting aspect of the deliberations of all groups."
- 3) Dr Chika Anyanwu recommends that people's contributions be acknowledged. As these contributions are useful intellectual properties. We suggest articulating this in the project's policy statement.
- 4) Dr Apollo Nsubuga-Kyobe suggests we request from each African Mission in Australia, information about critical projects needed by their country. In his view, this will assist us to develop targeted short and long term objectives.
- 5) A forum member recommends that each forum member provides titles specific to the African organization they head or is involved with.
- 6) We are taking action to get official recognition by the AU. Also, we are requesting that this project be auspice under the African Heads of Mission in Australia. To enable "The African Diaspora in Australia (& Asia Pacific) Project" achieve its fullest potentials, we asked the diplomats group to use their diplomatic knowhow to help us accomplish the following strategic objectives: (1) recognition by the African Union and; (2) auspice under the African Missions in Australia. Feedback from Ms. Fatma A. Abdallah, Second Secretary, Kenya High Commission, indicates that "H.E. Mr. Molosiwa Selepeng, the Dean of the African Diplomatic

- Corps in Canberra, will table this issue at the next meeting of African Heads of Mission and probably highlight it in the upcoming Australia Africa Conference 2014." (See emails Appendix 1 and 2)
- 7) As we progress, a secretariat will be established to manage the project's day to day administration.
- 8) If your name is missing from the above list or you wish to be added to more focus groups, please let us know.
- 9) We recommend that each focus group appoint a Chairperson and Secretary. The Chair and Sec will have a moderator status once your focus group's Google platform is created.
- 10) The above focus group stems from Dr Charles Mphande's suggestion that we adopt a grassroots approach and call for mapping of our skill sets. With each cadre working to come up with a strategy for achieving our objects and for change.
- 11) We may limit information flow to members of a specific focus group only. This is to prevent information overload. However, His Excellency, Mr Molosiwa Selepeng, the Botswana High Commissioner and Dean of the African Heads of Mission will be added to all focus groups as observer.
- 12) Dr Mimmie Claudine Ngum Chi Watts suggests that we "have a health (stand alone) or a health related category because of the disease burden and need in this area back in Africa." Suggested categories include: Gender and Health; and Health Research. On this, Mr David Malinda observes that "the moment we start dissecting the program the quicker people start getting confused and lost."
- 13) Ms Fatma Abdullatif Abdallah suggests that gender equality and empowerment issues require focused attention as enshrined in article4 (1) of the AU Constitutive Act, the UN MDG 3, and cutting across the post-2015 Development Agenda.
- 14) We've been inundated with invitations to attend conferences and participate in global discussions about Africa-International relations. To enable us elect representatives acceptable to the African communities in Australia and Asia Pacific region, we need to finalise the structure and processes for "The African Diaspora in Australia (& Asia Pacific) Project". On this, Dr Yohannes Yihdego Woldeyohannes and Dr Apollo Nsubuga-Kyobe suggests that really knowledgeable individual should be delegated to represent us at specific events within their expertise. It was suggested that, this is a key criteria in deciding who represent us and where. Following this, we shall ask our academic forum members to help formulate legal frameworks, policies and procedures for "The African Diaspora in Australia (& Asia Pacific) Project" operations.
- 15) Further, we suggest that leaders with resource (non-reimbursable), time and know-how represent us and their organizations at key diaspora, national or global events. This suggestion is an interim arrangement pending finalisation of the "The African Diaspora in Australia (& Asia Pacific) Project" structure, policies and procedures. This suggestion is made in good faith, with hope that we can capture all opportunities that will help the achievement of the AU Diaspora objectives within the Australia and Asia Pacific region. Mrs Eleni Bereded and Ms Fatma Abdullatif Abdallah supports this idea, given the limitation & challenge of funding.

- 16) Mr David Malinda suggests that we form a Diaspora subcommittee who would solicit and write submissions for funding from within and outside Australia for future events and projects. On this, we suggest that the professionals/entrepreneurs group assist with developing strategies for fundraising. (See below Appendix 1 for preliminary ideas)
- 17) As we move towards formalising the structure for "The African Diaspora in Australia (& Asia Pacific) Project", we suggest adopting a collaborative approach as part of our operational principles. This suggestion stems from the fact that, we already have peak African organisations in Australia and the Asia Pacific region that have developed distinctive competencies. To avoid duplication of activities, we suggest strengthening these organisations and helping them execute specific AU diaspora projects in which they have core competencies. In doing this, we suggest developing policies and procedures on how to select the qualified organisations, including collaborative methodologies, accountability and review mechanisms. Perhaps, our "Community Leaders" group can assist us with this task. Mrs Eleni Bereded supports this idea.
- 18) We suggest that the outcome of the conferences held in Washington DC, NewYork, Milbourne, Canberra and others organised or attended by members of this forum, be collated to assist us craft strategic projects for "The African Diaspora in Australia (& Asia Pacific) Project". (See Appendixes 4-7). We suggest that the Youth group undertake this task, particularly, recommending viable short and long term projects.
- 19) It is imperative that we follow due processes and best practice methodologies for setting up and implementing the AU Diaspora programs. We suggest that our Women group examine the setup, operations and constitution of successful diaspora organizations in other regions, including AU documents. And develop a working paper for the "The African Diaspora in Australia (& Asia Pacific) Project" operations.
- 20) As we progress, draft proposal from our focus groups will be merged to articulate the legal structure, policies and operational systems for the "The African Diaspora in Australia (& Asia Pacific) Project".
- 21) Any suggestions on we can improve are welcome.

To my mind, there may be manifold options available to us and some of them are as follows:

1. First and foremost, may I humbly and respectfully suggest that we touch base with those who kindly sent these invitations in order to enquire about potential travel and living allowances on offer?

From the onset, I wish to convey my gratitude and appreciation for spearheading this noble initiative; the 'African Diaspora in Australia and the Asia-Pacific Region Project'!

In your first Email addressed to us on 24 May 2014, you did mention the need to strengthening the African-Australian Relationship in light of various African Union (AU) declarations; notably the 'AU Declaration of the Global African Diaspora Summit' or the 'Report on the African Union Diaspora Ministerial Conference'. In your correspondence, you mentioned the opportunity to amalgamate our collective strength and voices towards a common goal which encompasses contributing to the formation of the 'African Diaspora in Australia and the Asia-Pacific Region Project' and setting its goals. In my opinion, fostering democracy and the rule of law in Africa may be among such noble goals. The fact that they are associated to the US Department of State and that they invited us to participate and to contribute to the 'Conversation about the US-Africa Leaders Summit' provides us with an opportunity to touch base with its members. Either to enquire whether they may assist with travel and living allowances in regard to your call for ideas on how we may finance the trip to the US: or to explore potential partnership with 'The African Diaspora in Australia and the Asia-Pacific Region Project' on the long run. Indeed, the NED has various programs that may benefit us (such as the 'Forum research Council' which consists in a group of international scholars and experts who works on behalf of the NED in order to offer a wide range of theoretical and intellectual perspectives in the field of democracy studies: http://www.ned.org/research/research-council).

2. Second, apart from contacting those from whom the invitations originally emanated (as suggested above), it would advisable to contact local stakeholders. Indeed, they might help us financially or assist in facilitating the contact with potential donators who would accept to contribute to our trip (this includes local private or public sponsors or entities; encompassing local governments, universities or NOGs). For instance, the US Embassy in Canberra (notably its 'Public Affairs' and 'Political Affairs' sections) could be contacted. Most specifically, Ambassador John Berry may be approached in order to enquire whether his embassy may help in financing our trip or in facilitating further contacts with potential donators such as the 'Australian-American Fulbright Commission' http://www.fulbright.com.au/. Prime Minister Tony Abbott may also be contacted since the US Ambassador and the Prime Minister of Australia are the co-chairs of the Fulbright Commission in Australia. The Fulbright Commission in Australia may not necessarily be able to help financially, but its members might enquire for help among its vast network of sponsors in Australia and in the US: http://www.fulbright.com.au/about/thecommission?layout=edit&id=72. It is possible that the US Embassy will be keen on actively

contributing in facilitating the presence of the African Diaspora in Australia and the region to the important events that are scheduled in Washington soon. Especially since it is highly on President Obama's diplomatic agenda and it will be the first high level consultation of its kind. Furthermore, the Obama's Administration is valuing strategies aimed at maximising the value and outcome of this summit (the United States-Africa Leaders' Summit). One such strategy consists in the fact that African leaders should come armed with strategies of engagement that are mutually beneficial both to the United States and Africa (http://www.brookings.edu/blogs/africa-in-focus/posts/2014/01/23-africa-leaders-summit-kimenyi). As John said in his Email dated 4 June 2014, we were warmly invited and encouraged to contribute to a strategic agenda for Africa through brainstorming 'on a range of issues from economic to social empowerment'. The US Embassy in Canberra details are as follows: http://canberra.usembassy.gov/contact.html.

- 3. John's Emails also relate to the 'Invitation to Diaspora Meeting at the Fraser Mansion' to be held in Washington (USA) on 28 June 2014 concerning the 'African Heads of States Summit' and the 'CFA African Diaspora Leadership Conference Call 2014 Ronald H. Brown African Affairs Series' scheduled for September 2014. The acronym 'CFA' actually refers to the 'Constituency for Africa' which consists in a network of (Non Governmental Organisations' (NGOs) in the US which aim to build organised support for Africa in the United States (http://www.cfanet.org/about-cfa/). Here is another link of interest on CFA's desire to 'harnessing the capacity building of the Africa Diaspora in building Africa': http://www.cfa-network.org/. They also focus on fostering 'cooperation among a broad-based coalition of American, African and international organisations, and individuals committed to the progress and empowerment of Africa and African people' (CFA, 2014). Furthermore, CFA also founded and sponsors the annual 'Ronald H. Brown African Affairs Series' mentioned in John's Email sent yesterday. This event to which we were warmly invited to contribute to is held in conjunction with the Congressional Black Caucus (CBC) Legislative Week every year in September. In this regard, the 'African-American Unity Caucus' (AAUC) is a program founded by the CFA and one of its core objectives is about establishing effective partnerships with public and private entities in Africa and within the African Diaspora worldwide in order to positively impact the US foreign policy; especially in Africa http://www.cfanet.org/cfa-aauc/). In this vein, both CFA and its program the AAUC may be of great relevance to our project on the long run! I would suggest that we contact them in order to enquire whether they may contribute to our travel or living expenses whilst attending the 'CFA African Diaspora Leadership Conference Call 2014 Ronald H. Brown African Affairs Series' mentioned in John's message! Alternatively, we may ask if they could recommend NGOs or any other donators among their extensive network of stakeholders who might help. Indeed, 'Bloomberg Philanthropies' will co-host with the 'US Department of Commerce' the first US-Africa Business Forum on 5 August 2014: http://www.bloomberg.org/press/releases/bloomberg-philanthropies-u-s-department-commerce-host-inaugural-u-s-africa-business-forum/. Contacting them in order to explore potential financial assistance might be advisable.
- 5. Finally, here is a web link on one of President Obama's core project on consolidating leadership in Africa; especially among its future generation of decision makers: http://youngafricanleaders.state.gov/washington-fellowship/. Each year, they intend to

organising a meeting in Washington called the 'Young African Leaders Initiative' (YALI) and to offer grants and fellowships. On the long run, such initiative may be of great relevance to the noble project spearheaded by John; for instance, through a referral system whereby the 'The African Diaspora in Australia and the Asia-Pacific Region Project' would advocate the inclusion of young African-Australians or young Africans living overseas in the YALI program. This may be done by identifying young talents and by facilitating the contact with those in charge of the YALI initiative and by encouraging young talented African-Australians to joining President Obama's YALI network online http://youngafricanleaders.state.gov/!



Dear John, and through you to all the others,

Thank you all who have represented us (African-Australians),in the Diaspora Discussion on African Leaders Summit, Washington, D.C., June 28, 2014. Following on my earlier communication, that I would not participate in this summit because it coincided with a symposium held at the La Trobe University Centre for Dialogue, Melbourne. This was another contribution the discussions that were taking place elsewhere.

Some of you might have noted the flyer and topics proposed. The symposium was well supported, attended, and substantial discussions, questions, answers, and some solutions came up in regard to African-Australia Diaspora (African-Australians), and the Australia-Africa relations. An abridged publication of the proceedings, and proposed way forward (recommendations) is being worked on. The key focal areas of the symposium were (1) Settlement into Australia, (2) Enhancing Resilience –thus growth, (3) Australia-Africa Relations –Historic, Policies, the Economics, key Issues in the relationship and the Dawn of 'New Africa and Diaspora' including the role of sports in the developments, and finally (4) Contemporary Issues in the Australia-Africa Relations: Politics, Security, Peace Making and Future. As well the roles played and activities collaboratively staged as part

of the Africa Day celebration in Australia were summarised. The symposium was the last event of the Africa Day celebrations but which can be dubbed as a forum for triggering issues, allowing debate over the matters, at the same time seeking solutions. Therefore symposium touched on: how the African-Australians arrive, settle (including where and why), grow (questions of inclusion, access, & equity, and contributions), and extension of their relationships with the original countries. Questions of enablers, context, purpose, policies, benefits, global dynamics, socio-politic, broad economic agendas and so on; all emerged in the discussions.

However, among the many outcomes of the symposium is a general agreement that even though Sub-Sahara Africans are non-homogeneous; due to a host of positive reasons, and the needs a critical mass in addressing many of the above mentioned issues, the "Hybrid African-Australian Identity" as an easy convenient way of having a strong cohort reference of the sub—Sahara people in Australia, it is a better way to go.

Also, this symposium concluded that it is high time to foster initiatives towards establishing an "Africa-Australia Institute" in Australia as a major central Agency through which some of the above matters could be addressed. This is added to the recommendation by the Inquiry into Australia's Relationship with the Countries of Africa (Joint Standing Committee on Foreign Affairs, Defence & Trade) in regard to the development of An African Studies Centre within the Federal Department of education.

It is my belief that in one way or another, some of the above matters will be within the jurisdiction of "The African Diaspora in Australia (& Asia Pacific) Project".

I am looking forward to making further contributions as we move into the tasks.
